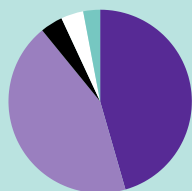

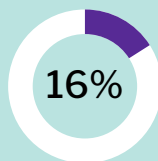

Nurturing Support for the Whole Family

Every Child Succeeds has been a lifeline, offering crucial parenting support from the very beginning for Eliana's family.

When her daughter was born, Eliana was referred to ECS, and her Home Visitor, Maria, became an invaluable resource. Through challenging months, she provided weekly in-home support, offering advice on sleep issues and guiding Eliana in stimulating her child's development. Maria also connected the family to important resources. Her consistent presence ensured that Eliana never felt alone; she became like family. The bilingual aspect added a layer of comfort, mirroring the family's home environment. Because of her partnership with ECS and Maria, Eliana's kids are thriving developmentally and socially.

Strategic Plan Progress

A Snapshot of Our Year

We introduced our new three-year strategic plan in our FY 2022 Report to the Community and are pleased to report our progress.

To advance family well-being, ECS provided an eight-session trauma-informed care training to equip our visitors with skills and tools to partner effectively with families and address secondary trauma. Further, we continue to make significant progress in developing new approaches that capture the voices of families and strengthen linkages with pediatric primary care. We are all in for optimizing children's development, prenatal to age three!

Advocacy is key to sustainability and impact. Every Child Succeeds had a significant role in the reauthorization of the federal Maternal, Infant, and Early Childhood Home Visiting (MIECHV) Program. Our two national program partners chose ECS from among hundreds of sites to tell the home visiting story. We welcomed Congressman Wenstrup to a roundtable event to hear directly from ECS mothers about how the program changed their lives. Congressman Wenstrup then championed the reauthorization of MIECHV, citing ECS in his comments on the House floor.

We will continue to implement our strategic plan priorities and advance the prenatal to three agenda.

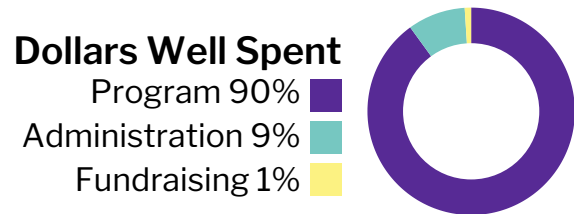
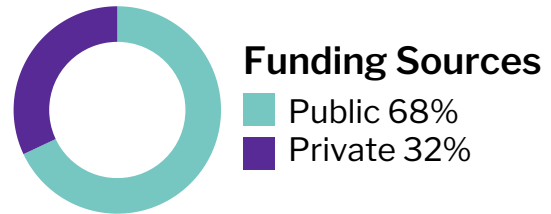
